In the light of the intention of Shatt Al-Arab University College and University of Naples Parthenope, to promote mutually beneficial co-operation in respect of education and research and with the desire to promote interinstitutional co-operation, scientific and cultural exchange, as well as mutual understanding and respect, the above-mentioned representatives of the two Institutions confirm their intention as follows:



The above institutions intend to promote mutually beneficial scientific, educational and other relations and to explore collaborative activities within mutually beneficial scientific and educational areas based on the following:

- Exchange of staff members for the purpose of research, training and teaching.
- Exchange of students.
- Collaboration in research
- Exchange of curricula and syllabus.
- Joint participation in EU, national or otherwise funded programs for international research and/or educational collaboration.
- Organization of conferences, seminars and symposia of mutual interest to the institutions.
- The exchange of information during scientific seminars, workshops or conferences on problems of interest to both parties.

## **ARTICLE 2**

In addition to the fields of co-operation stated in Article 1, University of Naples Parthenope and Shatt Al-Arab University College shall, in the spirit of this memorandum, also promote co-operation in other spheres and render help and assistance to one another taking due care not to cause harm or loss to either party.

## **ARTICLE 3**

Collaborative activities according to Article 1 shall be determined in a Memorandum of Cooperation with separate Annexes for each specific activity.

## **ARTICLE 4**

This Memorandum is drawn up in duplicate in English. It shall come into effect when the authorized representatives of both parties have signed it and shall be considered for review after a period of 5 years.

## **ARTICLE 5**



Either Party may withdraw from the Agreement by giving written notice before 31 December of any year of its intention to withdraw with effect from 1 September the next year.
